The Defence Society Residents Association (DSRA) is the oldest, largest and democratically elected Residents Association in the Defence Officers Housing Authority. It was registered with the Registrar of Society under number 4902 of 1978-79.

### **The aims and objective of the Association are:**

- \* To improve the living conditions of the residents of the Defence Housing Society. (now DHA) areas
- \* To develop civic sense in the residents of the Society. (now DHA)
- \* To foster voluntary participations of residents of the Society (now DHA) in solving their problems.
- \* To safeguard and look after the interests of members and residents of the Society. (now DHA)
- \* To promote such literary, cultural and social pursuits, as the Association may decide from time to time.
- \* To take steps as may be necessary and conducive to attain the above objectives through meetings, appeals, deputations or legal action.
- \* To raise funds to meet the expenditure incurred in achieving the above objectives.
- \* Establish phase-wise or in any other manner, the General Body may decide from time to time Chapters in Defence Housing Authority as and when deemed necessary.
- \* To promote social welfare activities to alleviate the sufferings of destitute and arrange financial and material assistance and the support for poor and needy persons.

The Association is completely non-political body and shall not be used as platform by any political body or individual for achieving any political objectives or ends.

Any person holding CNIC of Defence Housing Authority areas within the Clifton Contonment Board, (excluding adjoining Katchi Abadies) and owner of the property or resident of Defence Housing Authority, Karachi will be eligible for membership of the association.

Life membership is Rs. 1000/- ( One Thousand only) and Annual Subscription Rs. 500/- per anum.

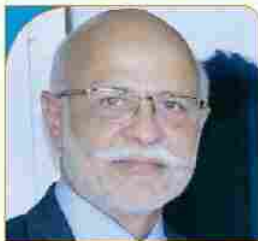

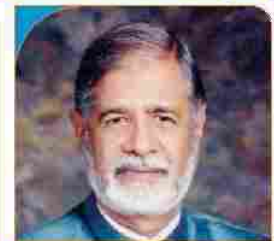

DSRA MEETINGS

MEETING WITH GOVERNORS SINDH

Honourable Muhammad Zubair



A delegation of Defence Society Resident Association (DSRA) headed by their President Mr. Sharfuddin Memon with Vice President Mrs. Tahira Athar and General Secretary Mr. Mansoor I. Usmani met with Mr. Muhammad Zubair, the Honorable Governor of Sindh on 21st March, 2018 at the Governor House Karachi, to seek his guidance and assistance in resolving the long standing water crisis in the DHA areas. The Governor Sindh had invited the senior officials from the concerned departments Karachi Water & Sewerage Board, Cantonment Board Clifton, Defence Housing Authority to participate to help find the workable solution. The Governor was assured that water crisis was linked with overall shortage in Karachi and tanker mafia; several measures was being taken to alleviate the situation but overall position will improve by implementing and expediting the K-4 Water Supply Scheme.

Honourable Imran Ismail



A delegation of Defence Society Residents Association led by Mr. Sharfuddin Memon called on Honorable Governor Sindh Mr. Imran Ismail at Governor House Karachi on 19th November, 2018, to appraise him the dire situation of water scarcity in the DHA areas making life difficult otherwise in this premium posh housing scheme of the provincial capital. The Governor Sindh who himself has his personal residence here in DHA felt deeply concerned and assured the delegation to put his weight in resolving the problem through short term measures but by seeking the federal assistance for installation of 10 MGD Water Desalination Plant.

DSRA Office Bearers led by its President Sharfuddin Memon met with the Honorable Chief Minister of Sindh, Syed Murad Ali Shah on 26th June, 2018 to discuss the Water Crisis and Traffic Issues. The Managing Director, KW&SB Mr. Khalid Mahmood Shaikh was invited by the Chief Minister to provide his views and solution for this long impending crisis

Mr. Sharfuddin Memon appreciated the CM for taking out time of his busy schedule and the effort and cooperation extended by the MD KWSB. CM Sindh acknowledged the issue of water shortage faced by the resident of DHA and promised to make efforts in alleviating this problem by undertaking short-term and long-term measures. Issue of short supply against allocated quota of 7MGD was raised by DSRA members to which MD KWSB promised fulfilment of this quota in next few days which was held up due to some technical issues.

Mr. Sharfuddin Memon appreciated the tankers being provided by KWSB on official rates to residents of DHA and requested that the cost of these tankers be brought down further to which MD KWSB promised to look into this possibility. He raised the issue of hardship faced by the

Senior Citizens of DHA by queuing up for receipt for each supply of tanker delivered and that the process should be simplified by CBC by issuing multiple receipts based on their allocated quota.

CM Sindh promised to work on various long-term measures for water supply including subsidizing capex by Sindh Government for establishment of new sea water treatment plant from the present of Rs. 0.70 per gallon to lower cost. He also considered to look into the possibility of Sindh Government taking over

and reviving of the DHA Co-generation plant.

CM Sindh confirmed that steps are already being taken to treat sewage water presently discharged in to the sea and recycling the same to provide treated water of up to 80 MGD to the industry which will help in alleviating the water shortages.

Mr. Sharfuddin Memon raised the issue of encroachments and illegal commercialization in particular beneath the Gizri Fly-over. DSRA CEC Members also pointed out the encroachment and conversion of Children Park adjacent to The Forum into car parking lot, thus hindering and depriving the surrounding localities of green breathing areas. CM Sindh promised to take measures in addressing all these issues at the earliest opportunity.



DSRA ACTIVITIES

INTER ACTIVE SESSION ON WATER CRISIS

An Interactive Session was held on Tuesday 1st May 2018 at the residence of DSRA President Mr. Sharfuddin Memon, in Gizri Boulevard, Phase 4. The DHA residents were invited to dilate and discuss the ongoing water crisis in DHA Areas. Some 200 residents, political leaders of all major parties had interactive discussion with MD

KW&SB on water issue. Mr. Memon regretted that representative of CBC & DHA were not present, although people's representatives like Dr. Arif Alvi, MNA-247 (now President of Pakistan.), Mr. Imran Ismail (now Governor of Sindh), Mr. Saamar Ali Khan, MPA (PTI), Mr. Najmi Alam (PPP), Dr. Ishtiaq Baig (PPP), former City Nazim

Syed Mustafa Kamal, Councilors of CBC and others participated in this session. Over all the meeting was a big success and DSRA achieved a commitment from MD KW&SB for the increase of water supply from 4.5 MGD to at least 7 MGD. The meeting concluded with a vote of thanks and a refreshing hi-tea.



HEARING AT SINDH WATER COMMISSION

DSRA President informed CEC about the hearing at Sindh Water Commission headed by Honorable Justice (R) Muslim Hani. DSRA was summoned by Sindh Water Commission as a petitioner through its President in the court of law. The representative of DHA, CBC and M.D KW&SB were present. DSRA was represented by President DSRA Mr. Sharfuddin Memon through their attorney & Head of Legal Sub-Committee Advocate Nasir Jahangir Riffat Shaikh. Vice President Mrs. Tahira Athar Nasim and Honorary General Secretary, Ar. Mansoor I. Usmani were also present. During the proceedings, Justice Muslim Hani formed a high profile committee headed by Deputy Commissioner with SSP of the area,



representative of KW&SB, DHA, CBC & President DSRA as the members, to investigate, monitor water supply pipeline from Chakra-Goth and any illegal connections on therein. The Court ordered M.D KW&SB to increase the water supply by 1 MGD by 17th December 2018. And by February 2019. KW&SB should stabilize water supply up to 07 MGD per day. The Court also decided to install flow meters gradually on the system.

President DSRA informed CEC we need up water supply up to 14 MGD for DHA to meet the increase in demand with new construction coming up.

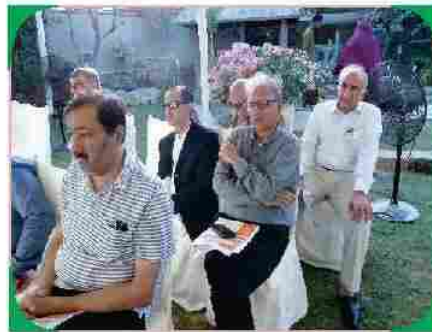
### ANNUAL GENERAL MEETING 2018

The event was attended by a large number of DSRA Members. The AGM concluded on vote of thanks by the VP (F) Mrs. Tahira Athar Nasim followed by refreshing hi-tea.

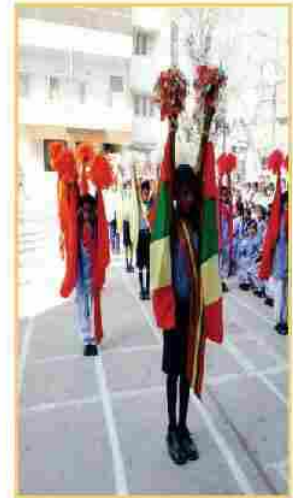
DSRA EDUCATIONAL & WELFARE TRUST

The DSRA Educational & Welfare Trust was established in 2005 to provide the standard quality education to the children of the underprivileged people in the DHA neighborhood, for their upward social movement in the society. Rear Admiral (R) Sajjad Akbar is the Chairman of the Trust that has 25 devoted and dedicated Trustees who had arranged sponsors for all students.

The DSRA School gradually starting from primary classes

now provides education up to matriculation. There are two branches of the school:

Defence Branch has 19 teachers and 223 students. Junejo Town Branch has 10 teachers and 131 students. The student strength will grow as registration and admissions for 2019 in Nursery class have been completed with an intake of 48 children.

**BASIC HEALTH CARE FACILITIES FOR ALL LIVING AROUND DHA**

DSRA Health & Welfare Trust has been running "DSRA Medical Centre" in Pak Jamhuria Colony since 2009. Around 255,000 people have benefited from the free medical facilities during the last nine years. The centre has a basic healthcare unit, family welfare unit and routine immunization unit. Additionally, ultrasound and pathological lab test facilities in cooperation with Essa-lab are made available for the patients.

**FREE CONSULTANTION MEDICINES AND VACCINATIONS**

DSRA Medical Centre has two doctors in morning session and three doctors in evening session (including a male doctor for male patients). Patients are provided free consultation along with medicines as prescribed by these experienced doctors. Around 150 patients visit this centre every day: Mondays to Saturday. Children and women are provided free vaccinations on Tuesdays and Saturdays. Morning: 10.00 am to 1.00 pm; Evening: 5.00 pm to 8.00 pm

**SEMINARS AND MEDICAL CAMPS TO CREATE AWARENESS**

We organize preventive healthcare seminars about common issues like chikungunya, breast cancer, stress, depression, obesity, oral cancer etc. Besides, we arrange medical camps in collaboration with Dr. Essa Lab, CCL Pharma and others to offer free test for bone mineral density, body mass index, blood sugar, blood pressure etc.
