- To take steps as may be necessary and conducive to attain the above objectives through meetings, appeals, deputations or legal action.

- ❖ To promote social welfare activities to alleviate the sufferings of destitute and arrange financial and material assistance and the support for poor and needy persons.

The association is completely non-political body and shall not be used as platform by any political body or individual for achieving any political objectives or ends.

Any person holding CNIC of Defence Housing Authority areas within the Clifton Cantonment Board, (excluding adjoining Katchi Abadies) and owner of the property or resident of Defence Housing Authority, Karachi will be eligible for membership of the association.

Life membership is Rs. 1000/- (One Thousand Only) and Annual Subscription Rs.500/- (Five Hundred Only) per annum.

#### **Transfer of Property Through Gift Deed**

There are two types of gift through which a property can be transferred to other person i.e a gift under transfer of property act and a gift under Muslim Personal Law. There are three essentials of a valid gift 1) Offer and willful intention of the donor to pass on the property to the donee 2) Acceptance of the donee and 3). Transfer of possession from the donor to the donee. However of transfer of possession under Muslim Law is not essential furthermore transfer of possession also not mandatory when the possession of the donor and donee is joint, before the execution of gift.

There are certain technicalities in the gift as per the evidence law which are stated below.

- 1. That every document which creates a financial liability should be attested by two marginal witnesses.
- That every gift which is in writing should be registered as per registration act 1807.
- That oral gift is acceptable subject to the evidence of two marginal witnesses.
- 4. That if the gift deed is lost or destroyed then the beneficiary of the gift may prove it through secondary evidence.
- Once the gift deed is registered, the presumption of geniuses shall go in favor of the gift, if the execution of the gift is not challenged.
- 4. That a gift can be revoked during the lifetime of the donor if the possession is not transferred between the donor and the donee.
- 7. Failure of entry in record of rights in favor of the donee shall not affect the gift.
